The slot-hole pattern will also accurately track through Gerber® 15" and friction-fed plotters. #129Y contains a yellow inner sheet of polyester which retains cut designs during liner removal. This same construction is found in #123, #124, and #154 stencil products. Recommended for single-process media blast carving of granite or marble.

The 30" will not work on large pin computer cutters. Replaces #123 in IBM® plotter applications.
